The Trust Persons must provide Punakaiki Fund permission to query these databases. By signing the application form, your Trust Persons will be deemed to have provided these permissions.

If electronic identity verification is unable to verify the identity of an individual Trust Person, then Punakaiki Fund will require copies of the following documents (certified by an appropriate person):

Common Reporting Standard
